2. (a) In case of any discrepancy in the marks shown in the Annexure for seniority and qualification in respect of any candidate, he/she is advised to get in touch with Personnel Dept. of concerned RO with advance copy of representation to us **immediately but not later than 13.10.2016** along with documentary evidence in support of his/her claim. Concerned RO may scrutinize / check the same and send their recommendations to Head Office for effecting necessary corrections.
- (b) It may be recalled here that this being 2016 Promotional Exercise, the eligibility criteria in terms of Para no. 07 of Notice dated 16.08.2016 shall be reckoned on 31.12.2015. However, Insurance qualification may be reckoned for the purpose of eligibility as also grant of marks for qualification if the result of the same were declared and proof of passing the examination was produced on/before the last date of submission of application for promotion i.e 22.08.2016_.
- (c) In view of this panel subject to rectification of discrepancies, if any, as indicated in 2(a) above, it is clarified that in the event of inclusion, if any, of fresh candidates as a result of rectification of such discrepancies, the cut off marks as indicated in (1) above are also subject to revision and the names of candidates securing less marks than such revised cut off marks are liable to be deleted from this panel, in order to meet the provisions of Para 10 of the Promotion Policy.
- (d) The tentative date of interview is from 21.10.2016. The final Panel cum Interview Schedule will be intimated shortly.
3. The promotions offered on conclusion of the Promotion Exercise would be provisional and subject to the outcome of OP No. 18750/99 before High Court of Kerala & WP No. 16006/99 of High Court of Madras and WP (C) No 24515/2014 of High Court of Kerala at Ernakulam and other similar orders from any Court or any case pending in any Court of Law.


