**A. Qualification:-**

The Candidate should be a Fellow Member or an Affiliate Member in accordance with the Actuaries Act, 2006 with specialization (as evidence by qualification and/or working experience) in General Insurance. He/she should satisfy all the requirements specified in Regulation No. 3 of IRDA (Qualification of Actuary) Regulations, 2004 (including amendments) and any other Act/Regulation, to the extent applicable.

**B. Age: (As on 01.11.2015)**

The candidate should preferably be over 35 years of age but not more than 60 years.

**(III) Duties and Obligations:-**

As per Regulation 8 of IRDA (Appointed Actuary) Regulations, 2000 (including amendments) and any other regulatory or legal requirement, to the extent applicable.  
Any other assignment/activity involving actuarial role.

**(IV) Emoluments and Benefits:-**

Negotiable. Please indicate your expectations.

**(V) Service Conditions:-**

Should be a resident of India and should be willing to stay in New Delhi.

After appointment he/she should not act as an Appointed Actuary of any other organisation. He/she is also expected not to practice in General Insurance for other Insurance Company or as a Broker or as a Surveyor.

Should not get engaged in any activity which gives rise to conflict of interest.
