- a. The *Chief Regional Manager*, *The Oriental Insurance co. Ltd.*, *Saheed Nagar*, *Bhubaneswar in Odisha* (herein after called the owner) invites bids on form attached hereto, all blanks of which must be appropriately filled in Bids will be received by the said trustee in his office on the date and time mentioned in the tender notice and will be opened in the said office in presence of the tenderer or their duly authorized representative if any.
- b. The envelopes containing the bid must be sealed and be, addressed to The Chief Regional Manager, The Oriental Insurance co Ltd. Saheed Nagar, Bhubaneswar, which shall be received **upto 20**th **May'2015, 3 P.M.**
- c. Any bid which is not prepared and submitted in accordance with the terms and conditions of the tender document will be considered incomplete. The owner, however, reserves the right to waive any infirmities/irregularities in the tender if it is deemed to be in the interest of the organization.
- Qualified contractor for this project while submitting bid for the works must furnish following documents.
 - a. The Tenderer shall furnish up to date income tax and sales tax certificates from the appropriate authority.
 - b. The Tenderer must submit details of construction equipment's, technical personnel etc. which can be deployed for the work.
 - c. The Tenderer must give a list of successfully completed works costing Rs. 3 lacs and above during the last three years with full address of the owner.
 - d. Item wise rates must be quoted for all items as per the schedule of items.
 - e. Any bid which is on a form not completely filled in or which is conditional and obscure or illegible or which contains any addition not called for shall be subject to rejection.
 - f. The complete form should be without inter lineation, alterations or erasing or over writings but if these are necessary to correct errors made by the bidder, these shall be initiated by the person signing the bid.
 - g. All Pages of the tender documents must be gone through and initialed by the some person signing the bid after duly affixing the seal of his/their firm.
 - h. If the bidder finds any provision of the contract document as being inconsistent and/or of doubtful application after through study of design drawings specifications and site he shall immediately object/inform the owner in writing.

- i. Earnest money deposit in the manner as shown in the tender notice should accompany the tender failing which the tender will be summarily rejected.
