- 2 Engineers/Consultant Shall mean the technical person who process the tender.

 - 4. The contractor should pay a sum of R. 20,000.00as Earnest Money Deposit along with the tender in the form of Demand Draft in favor of "ORIENTAL INSURANCE COMPANY LTD." drawn on any nationalized bank.

For small job the total security deposit minus EMD may be less than 10% of gross amount of R.A. Bill / Final Bill and in such cases only the actual amount due shall be deducted.

50% of the security deposit is to be refunded within 30 days after completion of work and issue of completion certificate to contractors after getting competent authority's approval.

Balance 50% of the security deposit shall be refunded within 30 days of expiry of defects liability period, after getting competent authority's approval provided it is certified that the contractors have attended to the defects and no defects rectification work is pending. No interest is allowed on retention money.

Alternatively, security deposit may be furnished in the form of one or • two (of like amount) bank guarantee(s) on any nationalized/scheduled bank preferably at place of work or Regional Head Quarter of Employer within whose jurisdiction the work falls. Provided he is otherwise satisfied. Bank Guarantees shall be as per specimen in conditions of contract. If one B.G. is submitted for full amount, it shall remain in force till defects liability period is satisfactorily completed.

If contractor furnishes two bank guarantees of like amount, one shall remain in-force till the period of virtual completion of work and issue of virtual completion certification and second shall remain in-force till the defects liability period.
