

5) The rates provided shall be inclusive of the transportation and installation cost at the requisite OICL office premises working under Ahmedabad Regional Office (140000). The separate rate should be provided for Buy-Back of Batteries.

6) In case of any malfunctioning of batteries under warranty at any OICL office premises it will be the sole responsibility of the vendor to cater to the problem and get it resolved. 


