3. The Comprehensive Annual Maintenance Contract shall include preventive maintenance service on monthly basis which includes cleaning of all parts and machine.

- 4. The Service Provider is responsible for maintaining multi-purpose fax machines in a perfectly working condition during the entire contract period and in case any part/parts of the machine is/are required to be replaced for proper functioning of the machine, the same shall be replaced free of cost. The replacement of parts, if required, shall be made within a reasonable period by the Service Provider. However, the cost of consumables and physically damaged plastic parts shall be paid by the Company.
- The Service Provider shall maintain 'Service/Complaint Card' in respect of each machine and get it signed from the user officer/department in certification of having carried out monthly service/repairs and attended complaints, if any.

- 6. The Service Provider shall submit photo-copy of 'Service/Complaint Card' duly signed and certified by the user officer/department along with the Half Yearly Bills to the Establishment Deptt. for release of payment. The payment shall be made within 15 working days from the date of receipt of bill alongwith photocopy of 'Service/Complaint Card'.
- The payment of AMC charges shall be made in two instalments on Half Yearly Basis i.e. first instalment after completion of first monthly preventive maintenance service and second instalment after completion of seventh monthly preventive maintenance service.
- 8. The vendor shall have to deposit Rs. 10,000/- (Rupees Ten Thousand only) as Security Deposit with the Customer.
- 9. In case multi-purpose fax machine is required to be taken to Service Provider's premises for repairs/replacement of parts etc., the Service Provider shall provide "Service Unit" in its place and bring back the original fax machine within 4-5 days duly repaired and in perfectly working condition.
- 10. The Service Provider shall be required to attend to complaints within 24 hours and carry-out repairs within reasonable time. In case the repairs to the machine is not carried out within reasonable time i.e. within 2-3 days, a penalty of Rs. 100/- per day shall be imposed and the same shall be adjusted from the bills/amount payable to the Service Provider.
- 11. The Service Provider shall provide monthly preventive maintenance service and attend complaints at the place of installation of multi-purpose fax machines mentioned in the enclosed list. The fax machines required to be shifted within the premises shall be carried out by the Service Provider free of charge. In case the fax machine is required to be shifted outside the premises of installation, reasonable shifting charges shall be paid by the Company.
- 12. The Service Provider does not cover any work necessitated by neglect, misuse, fire or accident. The cabling charges, if required for installation of machine, shall be paid extra by the Company.
