# Tender for providing Housekeeping Services at OSTC FINANCIAL BID(PRICE BID) (To be kept in Envelope No. 2) Instructions for submitting Financial Bid

- 1. Contractors are advised to quote the rates strictly in the Financial Bid ( Price Bid)
- 2. The rate should be quoted in Indian Rupees only.
- 3. All the columns should be clearly filled in ink legibly or typed. The amount should be filled in figures as well as in words.
- 4. No column should be left blank which would otherwise make the tender liable for rejection.
- 5. Housekeeping staff will be considered under un-skilled category, semi-skilled, skilled and highly skilled category as per Annexure A,B,C and D and the current rate of wages will be effective from 1.1.2012 as per Labour Commissioner, Haryana circular No. IR-II/8273-397 dated 21.2.2012 is mentioned in the relevant annexures.
- 6. If the above amount is increased then automatically the benefits 2(a) to 2(f) will increase and the total amount payable to Contractor at S.No. 5 below will also increase.
- 7. Minimum wages per month at S.No.1 and other statutory payments along with cost of amenities i.e, S.No. 2(a) to 2(f) of financial bid will be paid by the Contractor to workers and reimbursed to Contractor by OSTC as per Minimum Wages Act and other statutes in force and amended from time to time.
- 8. The rate quoted above will be per shift of 8 hours per person per month.
- 9. If the Minimum Wages are revised by the Government of Haryana or any other rates in respect of statutory payments are revised by Central or Haryana Government then amount payable shall be revised by OSTC accordingly.
- 10. Nature and design of Uniform and other accessories will be decided by OSTC and per month outgo will be approximately Rs. 250/- as mentioned in S.No.2(g) of financial bid. This amount will remain fixed throughout the contracted period of three years.
- 11. Mediclaim insurance will be arranged by the service provider and per month outgo will be approximately Rs. 150/- as under S.No..2(h) of financial bid. This amount will remain fixed during the contracted period of three years.
- 12. Percentage of Service/Administrative charges will remain fixed during the first year of the contract but the amount thereof will vary depending upon the total of S.No.1 + S.No.2a to 2 i = S.No.3 of the Financial Bid (Price Bid). On Satisfactory completion of first year of the contract, the administrative/service charges shall be increased by 10% of the previous year percentage, while renewing contract for the second and third year, For e.g. if the contractor quotes 10% service charges/administrative charges then for first year it will be 10%, 11% for second year and 12.1%. for the third year.
- 13. Necessary Statutory deductions such as TDS, Surcharge, Education cess, Higher education cess etc. will be made from the amount payable.
- 14. Service Tax and cess thereon, if any, will be paid in addition to amount quoted by the Agency
- 15. The contractor is advised to mention any other statutory requirement under col.2(i) specifically with the cost thereof. He should make a note that it will be contractor's responsibility to bear the cost of all statutory payments and no additional cost other than what is quoted by him in the financial bid shall be borne by the Company.
