a woman principal of a school to commit suicide. Additional Sessions Judge RC Dimri pronounced the order today in this regard.

According to prosecution, Rajni was working as a principal in Radha Lal Vidhya Mandir School at the Ambala City. She had committed suicide by jumping before a train at the Ambala City on March 7, 2007.

Later, the police had recovered a suicide note from her residence in which she had alleged that the cashier of the school, Vinod Kumar, had been harassing her and forced her to resign from the job. She had alleged in the suicide note that the attitude of Vinod caused her great mental tension.

On the complaint of Rajender Kumar, the deceased's husband, a case under Section 306 was registered against Vinod Kumar. Later, the Supreme Court had granted him anticipatory bail. According to counsel of the complainant, 16 witnesses were produced in the court.
